**MEMBERS IN ATTENDANCE:** Connie Hargis, Bob Mack, Carol Huff, Mayor Harold Goffinet, Clerk-Treasurer Susie Roberts, and City Attorney John Hargis. Absent: Ferman Yearby and Chris Brown.

**PLEDGE:** The *Pledge of Allegiance* was said by all in attendance.

**MINUTES APPROVAL**: The minutes from our August, 2014 meetings were not approved due to lack of members present.

**CHARLIE FINECY:** Charlie reported that he has already had a few groups of school children this year. He will be hosting the Young Professionals of Spencer County on September 17<sup>th</sup> at the museum. Also, on September 20<sup>th</sup>, the Friends of the Village will be hosting the Civil War ball at the courthouse. He will be attending the annual Lincoln Forum Symposium in Gettysburg, PA in November.
